5. Wildlife Conservation (Fauna Protection) Amendment Bill 2002

Hon Christine Sharp: To move on the next day of sitting -

That a Bill for "An Act to provide for the conservation and protection of fauna in cases where habitats are likely to suffer damage, or fauna will be subjected to interference or damage by intrusive activity, by amending the *Wildlife Conservation Act 1950* and including production contracts formed under the *Forest Products Act 2000*" be introduced and read a first time.

6. Australian Involvement in Military Action in Iraq

Motion No. 6 having been called.

Debate resumed on the motion of Hon Dee Margetts as follows -

That this House notes -

- (1) The recent comments from the Prime Minister and Minister for Foreign Affairs regarding Australia's possible support for US military action in Iraq.
- (2) That these comments were made in the absence of any United Nations resolution or processes.
- (3) The threat to the livelihood of Western Australian agricultural producers and exporters in light of the Prime Minister's indication that any request for Australian assistance would be considered against the "national interest test".
- (4) The statements from Labour Leader Simon Crean that Mr Howard's and Mr Downer's statements are out of step with other international opinion.
- (5) The likely impact on the civilian population, particularly women and children.

Therefore, the Legislative Council informs the Federal Government that is does not support Australian involvement in military action in Iraq without UN backing.

Debate ensued.

7. Statement by President - Contingent Notice of Motion

The President made the following Statement -

Yesterday at the request of the Minister for Housing and Works on a Point of Order I said that I would consider a Notice of Motion given by Hon Peter Foss, which appeared to contain a contingent element. The Minister referred to what he understood to be a ruling by a former President. In fact, it was a statement by Hon George Cash on June 24 1998 that ended with a request that Members refrain from moving contingent motions that would have a disruptive effect on the ordinary routine of business.

Contingent motions, although not described as such, are a common feature of the practice of this House. A motion to discharge an Order of the Day, or to give an instruction to a Committee, are both contingent in that they are dormant until the relevant Order of the Day is called.

I agree with the approach taken by Deputy President Cash. A motion is not out of order because it is made contingent on something else happening in the course of a day's proceedings. If, as seems to be the case in the Senate, a practice of using contingent motions to avoid other, more stringent requirements of the rules started to emerge, there would be cause for concern. Members of this House have not as yet demonstrated such a tendency.

When Order of the Day No. 72 is reached at today's sitting, the House will resume debate on the question for discharge of the second reading of the Bill and its referral instead to the Standing Committee on Public Administration and Finance. Were that question to be resolved affirmatively, Hon Peter Foss' motion would fall, for the simple reason that the contingency - the Order of the Day - had been discharged and no longer exists. If the discharge motion is lost, other issues may need further consideration.

8. Address-In-Reply

May it please Your Excellency -

We, the Members of the Legislative Council of the Parliament of Western Australia, in Parliament assembled, beg to express our loyalty to our Most Gracious Sovereign, and to thank Your Excellency for the Speech you have been pleased to deliver to Parliament.

Debate resumed.

Point of Order

The Leader of the House raised the following Point of Order -

I raise this Point of Order on the relevance of the Member's speech. The motion is an amendment to the Address-in-Reply motion, and it relates to questions about the Government's administration of the State. I understand that it is the convention that when a Member has already spoken on the substantive issue - that is, the Address-in-Reply - it is the practice to confine debate on an amendment to the narrow terms of the amendment. The narrow terms of the amendment - if an amendment as broad as this amendment can be defined in narrow terms, because it deals with the whole question of administration - nonetheless should be observed, particularly given the careful wording of the amendment dealing with such a broad issue.

President's Ruling

The President ruled as follows -

I take a broader view than the Leader of the House with respect to the definition of administration in the amendment. Indeed, listening to the Member's speech, one could take the view that the concern she was mentioning about the forest policy, the firebreak policy and so on is pertinent to the administration of the State, not in a narrow definition of administration. I take the point that the Member may need to relate any forthcoming comments to the amendment, not to the state of the Green Party or their prospect in other jurisdictions, which is pushing the definition of the amendment of relevance to administration of this State. However, most of speech I have heard has so far been relevant to the amendment and I trust the Member will ensure the balance is relevant.
