#### 1. Meeting of Council

The Council assembled at 11.00am pursuant to order.

The President, Hon John Cowdell, took the Chair and read prayers.

#### 2. Petitions

Hon Paddy Embry presented a petition, by delivery to the Clerk, [SO 130], from 506 residents of Western Australia requesting the supply of electricity to Windy Harbour. (Tabled paper 351).

Hon Simon O'Brien presented a petition from 46 residents of Western Australia opposing the Government's decision to change the route from Kenwick to the Kwinana Freeway reserve. (Tabled paper 352).

#### 9. Standing Committee on Environment and Public Affairs - Order of Reference

Hon Robin Chapple: To move on the next day of sitting -

In relation to the use of 245T and related toxins (the "chemicals") by the Agriculture Protection Board (the "APB"), the Standing Committee on Environment and Public Affairs inquire into and report to the House on the following -

- (a) the sources of supply, and the terms and conditions under which the chemicals were supplied to or acquired by the APB;
- (b) the purpose and extent of the use of the chemicals by the APB;
- (c) the form and content of the regulatory regime, and the physical conditions, under which the chemicals were supplied, stored, transported, handled, and disposed of by the APB;
- (d) the extent to which, and the means by which, the APB knew, or could reasonably be expected to know, of the dangers to human health associated with exposure to, or the use of the chemicals, and the degree of diligence exercized by the APB so as to ensure the currency of its knowledge;
- (e) the measures taken by the APB from time to time to protect its employees or contractors from unnecessary or potentially harmful exposure to the chemicals, and the criteria adopted by the APB in developing appropriate safety standards:
- (f) the response of the APB to health-related complaints from former employees or contractors allegedly caused by their exposure to or use of the chemicals; and
- (g) any other matter relevant to the matters contained in the preceding paragraphs.

#### 10. Select Committee into the Fremantle Eastern Bypass - Establishment

Motion No. 5 having been called.

Debate resumed on the motion of Hon Simon O'Brien as follows -

- That a Select Committee of five Members is appointed, any three of whom constitute a quorum, to inquire and report on the history of that part of the Metropolitan Region Scheme known as the Fremantle Eastern Bypass and related road infrastructure including -
  - (a) initial inclusion of the bypass in the Metropolitan Region Scheme;
  - (b) subsequent modifications to the Metropolitan Region Scheme in respect of the bypass;
  - (c) the decision making process and advice given to Government by relevant Government agencies including agencies responsible for Main Roads, Planning, Transport and Environment;
  - (d) directions given by Government to agencies with responsibility for decision making; and
  - (e) other matters pertaining to the history and possible future of the Fremantle Eastern Bypass that the Committee may consider useful to bring to the attention of the House.
- (2) The Committee have power to send for persons, papers and records and to travel from place to place.
- (3) Standing Orders 322, 323, 330 and 331 apply to the proceedings of the Committee and any contrary or inconsistent provision of Chapter XXIII is modified accordingly.
- (4) The Committee may present interim reports without a requirement for leave is to report finally not later than November 30 2002.

Hon Norman Moore moved -

That the words "That a Select Committee of five Members is appointed, any three of whom constitute a quorum" be deleted and the following words be substituted -

"That the Standing Committee on Public Administration and Finance be required".

Point of Order

The Minister for Racing and Gaming raised the following Point of Order -

I refer to Standing Order No. 97. Hon Peter Foss has referred to Hon Bob Kucera. The words used offend the Standing Order in that they reflect personally on the Minister for Health.

Deputy President's Ruling

The Deputy President ruled as follows -

I am interested in the Point of Order because I too had Standing Order No. 97 open to refresh my memory when Hon Peter Foss was referring to a person by the name of Kucera. Hon Peter Foss has made it clear that he is relying on a poster and is suggesting that others printed a poster with certain words on it. To date, the qualifications made by the Member would not constitute a breach of Standing Order No. 97. However, if there is any attempt to impute improper motives to Hon Bob Kucera, who is the Minister for Health and a Member in the other place, I will be drawing Hon Peter Foss's attention to the Standing Order. It is possible in a debate to relate to a fact as one knows it and to date that is what has occurred. I am listening very carefully to what is being said.

Debate resumed.

Point of Order

The Minister for Racing and Gaming raised the following Point of Order -

I am looking at Standing Order No. 97. Hon Peter Foss is quoting from a document. As I understand it, he is using the words of somebody else. However, he is still using words and those words are in reference to another Member of Parliament, Hon Bob Kucera, and those words impute improper motives and/or personally reflect on that Member. I object to those words being used because I think it is inappropriate that an imputation of improper motive or a personal reflection be made.

Deputy President's Ruling

The Deputy President ruled as follows -

I understand that the statement that has been referred to has been raised by Hon Peter Foss in support of a view that he is putting that the Government should take action over an issue that he has raised. It is true that Hon Peter Foss has referred to the statements of another and it seems to me that he should qualify at some stage that he is referring to the statement of another and that he believes that statement is material and relevant to the view that he had represented and it is not intended by him to cast any imputation of improper motives about a Member of the other House. In the end, if Standing Order No. 97 were taken to its clinical conclusion, very little would be said about anyone in this place without attracting that view.

I reached for my Standing Orders before the Minister for Racing and Gaming because I anticipated what could have been said and I will not have any reflection on another Member in breach of Standing Order No. 97. Tempered by my comments, I must also have regard for the ability for there to be robust debate on various issues in this place. I am listening intently to ensure that there is no direct imputation of improper motives or personal reflections by the Member speaking against a Member of the other House and, if there is, I intend to stop the Member immediately.

At the moment, the Member is apparently referring to another statement. However, we are all Members of a House of Parliament, whether it be the Legislative Council or the Legislative Assembly. I must have regard for the interests of Members of the Legislative Assembly as I do for those of the Legislative Council. Hon Peter Foss has been in this Parliament long enough to understand and know the meaning of Standing Order No. 97. It is fair to say that he has couched his remarks having regard for the provisions of Standing Order No. 97. However, the Honourable Member did not take up my previous suggestion. Therefore, I say again that he should confirm to the House that he, as a Member of this place, is not intending by his comments to raise any imputations of improper motives or personal reflections against a Member of the other House, Hon Bob Kucera, the Minister for Health. Earlier in the Member's speech, he mentioned the name Kucera and I did not stop the Member there and then - perhaps I was wrong - to qualify whether he was referring to Mr Kucera, the Honourable Member in the other House and Minister for Health, or Mr Kucera, a former member of the Western Australia Police Force, or some other Mr Kucera. It is not unreasonable to raise issues that might reflect on someone's previous employment. Notwithstanding that, if that same person is a Member of the other House, then Standing Order No. 97 will come into play.

Debate resumed.

On the motion of Hon Bruce Donaldson the debate was adjourned to the next sitting.
