1113. Hon Martin Aldridge to the Minister for Emergency Services:

I refer to question on notice 840 relating to engine exhaust emissions, and I ask, will the Minister table the report and any advice provided by the occupational hygienist in 2019 in relation to the static sample air quality monitoring conducted?

1114. Hon Martin Aldridge to the Minister for Emergency Services:

I refer to question on notice 660 answered on 10 May 2022 in relation to mobilisation of Brigades, Groups and Units (BGU), and I ask:

- does it remain the case that the Department of Fire and Emergency Services (DFES) does not record instances of non-response by a BGU when mobilisation is requested;
- (b) is it the case that DFES relies entirely upon commercial telecommunication networks for the mobilisation of BGU's including redundancy options all relying on the same network(s);
- (c) is the Minister aware that in other jurisdictions that emergency service organisations only rely upon telecommunication networks as a redundancy to their primary mobilisation being radio network based; and
- (d) what risk analysis or planning has been undertaken in the event of mass telecommunication loss affecting a region or even the entire State?

- (d) how does the volume of water identified in (b) and (c,) compare with the previous generation of light tankers;
- (e) is the Minister aware that the speedometers of these vehicles are not displaying accurately arising from different sized tyres being fitted and, if yes, what action is being taken to rectify this;
- (f) what limitations are placed on the vehicles towing capacity with a full tank of water;
- (g) please identify the Volunteer Fire and Rescue Stations (VFRS) that continue to utilise a rescue trailer (or similar);
