  - (i) 66 years or older?

# 6496. Mr S.K. L'Estrange to the Minister for Local Government; Heritage; Culture and the Arts:

I refer to the conclusion by Supreme Court Justice Tottle in Town of Cambridge v The Hon David Templeman that the "immediate suspension of the Council is so disproportionate to the limited nature of the Council's suspected failure that it is not a form of intervention that a Minister acting reasonably would order," and I ask:

(a) What steps has the Minister taken to ensure that all future actions taken with regard to the Town of Cambridge will be both reasonable and proportionate?

I refer to table 1.1 Appendix 1 of Budget Paper No. 3, being the Operating Statement for the General Government sector, which shows Salaries cost of \$12.887 billion in 2019-20 being \$292 million higher than the estimated result published in the 2019-20 March Quarterly report of \$12.595 billion with the Salaries cost for the June quarter expected to be \$3.096 billion, yet the final result was \$3.388 billion for the quarter, and ask:

(a) Can the Treasurer please provide a breakdown and explanation for the \$292 million increase in Salaries cost?

#### 6502. Dr D.J. Honey to the Minister for Water:

I refer to the Water Corporation, and ask:

(a) Can the Minister please provide a breakdown of the capital expense by major project for the 5 years from 2016 to 2020 and for the Forward Estimates?

# 6503. Mr P.A. Katsambanis to the Minister for Mines and Petroleum; Energy; Industrial Relations:

I refer to the workplace accident at Curtin University on 13 October 2020, and ask:

- (a) In the past 12 months how many safety complaints did WorkSafe receive about Curtin University;
- (b) If yes to (a) what were the dates they were received;
- (c) What action did WorkSafe take regarding each complaint;
- (d) How many inspections has WorkSafe conducted at the site in the past 12 months; and
- (e) What action did WorkSafe take in each case?

### 6504. Mr P.A. Katsambanis to the Minister for Police; Road Safety:

I refer to the introduction of new mobile phone penalties on 1 September 2020, and ask:

- (a) How many mobile fines were issued in September; and
- (b) How many mobile fines were issued in October?

### 6505. Mrs A.K. Hayden to the Minister for Tourism:

- (f) Is this expansion expected to require a desalination plant and if so, what is the estimated costing?

### 6508. Mrs A.K. Hayden to the Minister for Sport and Recreation:

I refer to page 564 of the 2020-21 Budget Paper 2, Volume 2, that has allocated \$20m in funding for Kiernan Park Recreation Precinct and I ask:

- (a) Could the Minister please provide a detailed list of the specific facilities and services the \$20m funding will be allocated towards;
- (b) What is the corresponding estimated cost of each facility or service listed in (a);
- (c) Was there a business case presented to the relevant State Government department for this project;
- (d) If yes to (c), how was the business case assessed, and by whom;
- (e) Was there a process involved for approving the funding of this project;
- (f) If yes to (e), what was involved in this process; and
- (g) Could the Minister confirm any relevant dates in the process for allocating funding to this project and could the Minister please include the dates when:
  - (i) The funding application was made;
  - (ii) The business case was submitted;
  - (iii) The business case was assessed; and
  - (iv) The funding application was approved?

#### 6509. Dr D.J. Honey to the Minister for Water:

I refer to page 15 of the 2020 Water Corporation Annual Report, which shows a 2019-20 interim dividend of \$613 million compared to page 222 of the same report, which shows a proposed final dividend of \$642 million, and ask:

- (a) Can the Minister please provide an explanation for this increase; and
- (b) Provide the accounting and/or dividend reporting standards by which this proposed, and therefore accrued dividend of \$642 million, is not being declared in the 2019-20 financial statements?

#### 6510. Dr D.J. Honey to the Treasurer:

Will the \$600 power credit per household from the WA Inc Bell Group Settlement be used to recoup any overdue and/or outstanding debts:

- (a) If so:
  - (i) What is the estimated total amount and number of household to be recouped; and
  - (ii) What is the breakdown by suburb of the amount and number of household accounts that is to be recouped?

### 6511. Dr D.J. Honey to the Minister for Energy:

Will the \$600 power credit per household from the WA Inc Bell Group Settlement be used to recoup any overdue and/or outstanding debts:

- (a) If so:
  - (i) What is the estimated total amount and number of household to be recouped; and
  - (ii) What is the breakdown by suburb of the amount and number of household accounts that is to be recouped?

I refer to Water Corporation pipelines, and ask:

- (a) Can the Minister please provide an annual breakdown for the 5 year period from 2016 to 2020, for the following:
  - (i) Leakage from Water Corporation pipelines in the South West Integrated System; and
  - (ii) The cost for attending to and repairing these leakages?
