 - (8) If unable to stand because of illness or disability, by permission of the Speaker, a Member may cast their vote with the ‘Ayes’ or ‘Noes’ while seated.
 - (9) The Speaker will declare the result of the division.
- (2) Standing Orders 137, 138, 140 and 141 in relation to divisions remain unchanged.
 - (3) Standing Orders are suspended accordingly to the extent necessary to effect these arrangements.
