- (2) Improved customer service was a nominated essential requirement to result from the dissection of the Western Power single energy utility into four separate entities. My electorate of Avon is inundated by constituent complaints regarding the performance of Synergy and others. I therefore ask the Minister what are these customer service benefits?

Two years ago I wrote to the Minister on behalf of a constituent who had advised me that there was a 12–18 month waiting list to access the Pain Relief Clinic at Fremantle Hospital. At the time, the Minister confirmed that was correct because there was only one pain specialist available. The Minister also advised that a review of the outpatient clinic operations and procedures was being undertaken with the aim of reducing waiting times and improving patient access. As constituents are advising me that they are still experiencing 12–18 month delays, can the Minister advise:

- (a) who undertook that review;
- (b) when was it completed;
- (c) what was the outcome;
- (d) is a copy of the review available to the public; and
 - (i) if so, could I be issued with a copy;
- (e) what new procedures are in place to improve wait times at the Pain Relief Clinic at Fremantle Hospital following the review;
- (f) the name of each of the State-operated pain management clinics;
- (g) in relation to (f), which ones have individual pain management clinics;
- (h) what is the average current waiting time and how many patients are waiting for treatment at:
 - (i) the Pain Relief Clinic at Fremantle Hospital; and
 - (ii) each of the clinics at other hospitals or community health centres as per (f);
 - (iii) what individual pain management services are available for patients and how do they access them;
- (i) what group pain management services are available for patients and how do they access them;
- (j) what pain management services are available for patients who may have a poor command of English or may be experiencing the beginnings of dementia and cannot join in on group sessions; and
 - (i) what funding allocations were made to the Pain Relief Clinic at Fremantle Hospital and at the other clinics listed in (f) for the following financial years:
 - (ii) 2001–2002;
 - (iii) 2002–2003;
 - (iv) 2003–2004;
 - (v) 2004–2005;
 - (vi) 2005–2006;
 - (vii) 2006–2007; and
 - (viii) 2007-2008?
