In relation to Question on Notice No. 3753, where the Minister stated that under the *Perth Theatre Trust Act 1979* the Perth Theatre Trust (PTT) is still ultimately responsible for setting strategic directions and ensuring the arts venues are accessible both to the performing arts sector and the community through positive programming and venue management initiatives, I ask:
