# MINUTES OF PROCEEDINGS

# WEDNESDAY, 21 MARCH 2007

## 1. Meeting of Council

The Council assembled at 4.00pm pursuant to order.

The President, Hon Nick Griffiths, took the Chair and read prayers.

## 2. President's Ruling - Matter of Privilege

The President ruled as follows -

On 20 March 2007 the Hon Giz Watson moved for the appointment of a select committee of privilege to inquire into a possible breach of privilege. Under Standing Order 155 it is for the President to rule whether the matter is one affecting the privileges of the House under the *Parliamentary Privileges Act 1891*.

I have considered the matters raised and how the Standing Order should be applied. First I interpret Standing Order 155(4) to mean I must rule if the matter is one that *affects* the privileges of the House, that is - whether the matters raised by the member establish that there may have been a breach of privilege. It is not my role as the presiding officer to determine if there has been a breach. The determination of whether or not there has been a breach is a matter for the select committee, if one is appointed.

Section 1 of the Parliamentary Privileges Act 1891 provides:

The Legislative Council and Legislative Assembly of Western Australia, and their members and committees, have and may exercise—

- (a) the privileges, immunities and powers set out in this Act; and
- (b) to the extent that they are not inconsistent with this Act, the privileges, immunities and powers by custom, statute or otherwise of the Commons House of Parliament of the United Kingdom and its members and committees as at 1 January 1989.

Erskine May comments on the disclosure of a committee's proceedings or evidence as follows:

By the ancient custom of Parliament "no act done at any committee should be divulged before the same be reported to the House" ....

The publication or disclosure of proceedings of committees conducted with closed doors or of draft reports of the committees before they have been reported to the House will, however, constitute a breach of privilege or a contempt.

Standing Order 328 aligns with this privilege. It states proceedings of a committee are not noticed by the Council until reported.

The matters presented by the Hon Giz Watson are matters affecting the privileges of the House

I therefore rule there is a matter of privilege and the order of the day is to be called forthwith.

## 3. Select Committee of Privilege

The Order of the Day having been called, debate resumed on the motion of Hon Giz Watson as follows -

That -

- (1) A Select Committee of Privilege be appointed to inquire into and report on -
  - (a) whether there has been any disclosure of deliberations of the Standing Committee on Estimates and Financial Operations relating to a proposed inquiry into the State's Iron Ore industry;
  - (b) if so, whether such disclosure constitutes a breach of the privileges, or is a contempt, of this House; and
  - (c) if the Committee so finds, what penalty, if any, the House might impose for the breach or contempt.
- (2) The Committee have access to documents in the possession or under the control of the Standing Committee on Estimates and Financial Operations relevant to the inquiry.
- (3) The Committee, and the proceedings of the Committee, are subject to Chapter XXII of Standing Orders and it is to be regarded for all purposes as a committee appointed under that Chapter.
- (4) The Committee have power to meet at any time when the Legislative Council is not sitting or a sitting is suspended.
- (5) The Committee may present interim reports without a requirement for leave and is to present its final report to the House not later than Wednesday, 30 May 2007.

The Leader of the House moved to amend the motion as follows -

That paragraph 3 be deleted and to insert instead -

"

The Committee have power to send for persons, papers and records and to travel from place to place.

,

Debate ensued.

Amendment - put and passed.

Motion, as amended, agreed to.

#### 4. Petitions

Hon Helen Morton presented a petition from 4 320 residents of Western Australia requesting the Legislative Council oppose the closure of Royal Perth Hospital. (Tabled paper 2394).

Hon Simon O'Brien presented a petition from 285 residents of Western Australia requesting the Legislative Council support the call for a referendum of daylight savings before October of 2007. (Tabled paper 2395).

#### 6. Governance and Administration

Hon Norman Moore: To move on the next day of sitting -

That this House expresses its grave concern at the significant deterioration in the governance and administration of the State of Western Australia resulting from a Government preoccupied with continued internal division and conflict, manipulated by outside influences and increasingly demonstrating serious signs of dysfunctionality, and calls on the Government to urgently address the issues raised by the Corruption and Crime Commission and refocus its attention on restoring public confidence in the capacity of the Government to govern for all West Australians without fear or favour.

#### 7. Commission on Government - Call for Establishment

Hon Giz Watson: To move on the next day of sitting -

That in the light of evidence presented to the Corruption and Crime Commission concerning lobbying and alleged public sector misconduct, this House calls upon the Government to establish a second Commission on Government to -

- (1) Audit the implementation of the first Commission on Government's recommendations and consider whether further implementation is required;
- (2) Consider whether alternative or additional reforms to those proposed by the first Commission on Government are required to prevent corrupt, illegal or improper conduct by public officials (including State Members of Parliament, Local Government Councillors and employees of State and Local Governments);
- (3) Carry out its inquiries in an open and participatory manner; and
- (4) Report to both Houses of Parliament within one year from establishment of the Commission.

## 8. Kojarena Satellite Ground Station - Expanded function

Hon Giz Watson: To move on the next day of sitting -

That this House -

- (1) Notes that the Federal Government has announced an expanded function of the joint US spy satellite ground station at Kojarena near Geraldton.
- (2) Notes that this expanded function will coordinate US military operations in the Middle East and Asia, making this the most significant military encroachment into Australia since signing of the Pine Gap Treaty of 1966.
- (3) Condemns the Federal Government for committing to this expanded function without consulting with the people of Western Australia, the City of Geraldton and the Premier.

## 9. Procedure and Privileges Committee - Referral of Tabled Paper

The Leader of the House moved, without notice -

That Tabled Paper No 2380 tabled in this House on 20 March 2007 being correspondence between the President and the Corruption and Crime Commission be referred to the *Procedure and Privileges Committee* for consideration and report on or before Wednesday, 4 April 2007.

Debate ensued.

Question - put and passed.

## 10. Home Ownership Affordability

Motion No. 46 having been called.

Debate resumed on the motion of Hon Ray Halligan as follows -

That this House condemns the Government for the undue anxiety created for the many first home buyers through its inability in a timely manner to -

- (1) Help reduce the cost pressures on residential land.
- (2) Help reduce the supply and cost pressures associated with skilled labour.
- (3) Meet its election commitments to -
  - (a) address housing affordability;
  - (b) increase social housing stock; and
  - (c) encourage and enable home ownership.

- and the Legislative Council Estimates and Financial Operations Committee, as appointed by the Houses from time to time;
- (b) the Chairman of the Public Accounts Committee will be the Chairman of the Joint Standing Committee; and
- (c) the Standing Orders of the Assembly relating to standing and select committees will otherwise be followed as far as they can be applied."

and requests the Legislative Council to agree to a similar resolution.
