The Governor transmits to the Legislative Assembly a copy of a despatch which he has received today from the Honourable the President of the Senate of the Commonwealth of Australia, notifying that a vacancy has happened in the representation of the State of Western Australia in the said Senate.

Government House  
Perth, 19 April 2022

“Your Excellency

Pursuant to the provisions of section 21 of the Commonwealth of Australia Constitution, I notify your Excellency there is a vacancy in the representation of the State of Western Australia following the resignation of Senator Ben Small on Friday, 15 April 2022.

In announcing his resignation, Senator Small indicated that there were questions as to his previous eligibility to sit as a Senator, which may need to be referred to the Court of Disputed Returns. However, those questions do not go to the manner of filling the current vacancy. This is a casual vacancy to which section 15 of the Constitution applies.

For clarity, I indicate that the term of the vacant position expires at the end of 30 June 2022.
