(1) Would the Minister please list by name and purpose, all committees involved in agriculture that report to or consult with the Department of Primary Industries and Regional Development?

Agriculture Minister's Forum – a Commonwealth forum of all state & territory Ministers - focusses on priority issues affecting Australia's primary production sectors.

Agriculture Senior Officials Committee – supports the Agriculture Minister's Forum to achieve its objectives.

National Biosecurity Committee – subcommittee of the Agriculture Senior Officials Committee responsible for a national, strategic approach to emerging and ongoing biosecurity policy issues, including those relating to the environment, across jurisdictions and implementing the Intergovernmental Agreement on Biosecurity.

Animal Health Committee - is a subcommittee of the National Biosecurity Committee, the purpose of which is to develop science-based and nationally consistent policy on animal health issues, and to provide advice as necessary on animal health.

Research and Innovation Committee - is an advisory committee of Agriculture Senior Officials Committee responsible for the oversight of the implementation of the National Primary Industries Research Development and Extension Framework.

Environment and Invasives Committee – is responsible for providing national policy leadership on the identification, prevention and management of invasive plant, vertebrate and invertebrate species that adversely impact the environment, economy and community.

Plant Health Committee is a subcommittee of the National Biosecurity Committee, the purpose of which is to maintain or improve plant health in Australia in support of the economy, environment and community through strategic policy, technical and regulatory advice and national leadership on plant biosecurity matters.

Legislative and Governance Forum on Gene Technology – is the ministerial group with oversight of the gene technology regulatory scheme and policy principles under the intergovernmental Gene Technology Agreement.

Gene Technology Standing Committee – provides high level support to the Legislative and Governance Forum.

WA Gene Technology Interdepartmental Committee - provides advice to the Office of the Gene Technology Regulator on genetically modified organism dealings.

Subcommittee on Plant Health Diagnostics - subcommittee of Plant Health Committee, which coordinates the development of National Diagnostic Protocols, for priority plant pests, develops and implements the National Plant Biosecurity Diagnostic Strategy, coordinates the National Plant Biosecurity Diagnostic Network, assists the development of diagnostic tools and material, facilitates and coordinates the delivery of training to diagnosticians and facilitating the progression of laboratory accreditation and proficiency testing.

Subcommittee on National Plant Health Surveillance - is a subcommittee of Plant Health Committee, responsible for the establishment of the National Plant Health Surveillance framework including the development of a nationally coordinated plant pest surveillance system in collaboration with jurisdictions and industry.

National Management Group (NMG)/National Biosecurity Management Group (NBMG) - is the decision making body on national exotic plant pest and animal disease eradication programs under the Emergency Animal Disease Response Agreement (EADRA), the Emergency Plant Pest Response Deed (EPPRD) and the National Environmental Biosecurity Response Agreement (NEBRA).

Consultative Committee on Emergency Plant Pests - is Australia's key technical body for coordinating national responses to emergency plant pest incursions and is convened in response to a plant biosecurity incident.

Consultative Committee on Emergency Animal Disease - coordinates and makes decisions on the national, technical response to emergency animal disease incidents of animal health, public health or trade significance.

National Research Development and Extension Committees below whose purpose is to promote more collaborative, specialised research, to have larger critical mass and decrease fragmentation across Australia:

Threatened Species Scientific Committee - is an independent committee of eminent conservation scientists that provides the Minister for the Environment and Energy with advice on matters relating to listing, conservation and recovery of threatened species and ecological communities, and listing and abatement of key threatening processes under the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act).

Northern Australia Biosecurity Framework Reference Group - advises on and supports a collaborative approach to biosecurity in northern Australia.

Cattle National Livestock Identification System Working Group – discuss and consult on issues related to the system.

National Livestock Identification Scheme Pigs Advisory Committee - Ensure a collaborative and nationally consistent approach to the implementation of pig traceability legislation and standards that underpins the meat integrity system.

National Wild Dog Action Plan Stakeholder Consultative Committee - provides leadership and coordination for the management of wild dogs.

Centre for Invasive Species Solutions Project Portfolio Steering Committee (Wild Dogs) – aims to advance solutions for invasive species management.

Centre for Invasive Species Solutions Project Portfolio Steering Committee (Feral Deer) – aims to advance solutions for invasive species management.

Pilbara Mesquite Management Committee - Management of mesquite in the Pilbara.

Lake Argyle Rubber Vine Advisory Committee - Management of the core infestations of the aggressive Rubber Vine weed in the Lake Argyle region.

West Kimberley Rubber Vine Advisory Committee - Management of the core infestations of the aggressive Rubber Vine weed in the West Kimberley region.

Western Dairy Research & Development Hub – purpose is governance of expenditure of State Government and Dairy Australia expenditure on dairy Research and Development in WA.

Freight and Logistics Council of WA – purpose is to discuss and progress issues of strategic importance to the states freight and logistics activities.

DPIRD Animal Ethics Committee – purpose is to oversee research activities to ensure the use of animals for scientific purposes is justified, has scientific/educational merit, aims to benefit humans, animals or the environment and is conducted with integrity.
