## Introduction

This report has been prepared for submission to the Minister, and subsequently each House of Parliament, in accordance with section 175ZG of the *Electoral Act 1907* (the Act). The purpose of this report is to summarise the operation of Part VI of the Act during the 2020–2021 financial year.

The Commission concluded its review of fifteen registered political parties in the first half of the 2020–2021 financial year. The review was conducted to verify the eligibility of the political parties to remain registered and included nine political party membership audits. The outcome of the review confirmed the eligibility of all fifteen political parties to remain registered prior to the State election held on 13 March 2021.

The 2021 State General Election was held during the 2020–2021 financial year, the effect of which was an increase in political party activity. Four political parties were successfully registered prior to the election, bringing the number of registered political parties to nineteen. There was a 10% increase in the number of candidates contesting the 2021 State General Election compared to the 2017 State General Election. The number of other persons who incurred electoral expenditure and lodged a disclosure return for the 2021 election was less than the 2017 election; seven compared to twenty in 2017. Election returns, which were not of a nil disclosure, were published on 26 July 2021.

The total reimbursement for electoral expenditure from the 2021 State General Election was \$5 million. Seven political parties and two Independent candidates were eligible to claim reimbursement, compared to the same number of political parties and five Independent candidates that were eligible to claim reimbursement for the 2017 State General Election. Claims for reimbursement were required to be lodged by 2 August 2021 and were published on 30 August 2021.

Nineteen registered political parties, as well as four unregistered political parties, lodged annual returns for the 2020–2021 financial year. In addition, seven associated entities complied with disclosure requirements by lodging an annual return. # Summary of disclosures and public funding through the 2020–2021 financial year

## 1. Financial disclosures

### 1.1 Annual returns by political parties and associated entities

- \$24,570,481.47 in gifts and other income was declared by twenty–three political parties.
- \$2,521,432.00 in gifts and other income was declared by seven associated entities.

Under section 175N(5) of the Act, political parties and associated entities are entitled to meet their State disclosure obligations by lodging the same return prepared for the Australian Electoral Commission under the *Commonwealth Electoral Act 1918 (CEA)*<sup>1</sup>, if they are obliged to submit a Federal return. Five political parties and six associated entities met their disclosure requirements by submitting their Federal return for the 2020–2021 reporting period.

### 1.2 2021 State General Election disclosures

The disclosure period for gifts received by political parties, candidates, Legislative Council groups, and other persons that participated in the election ended on 12 April 2021. Election returns were required to be lodged by 28 June 2021 and were available on the Commission’s website from 26 July 2021.

- \$697,742.65 in gifts was declared by candidates and other persons.
- Gifts not disclosed by party-endorsed candidates are incorporated into the annual return of the relevant party.
- \$13,586,129.35 in electoral expenditure was declared by political parties, candidates, Legislative Council Groups, and other persons.

- 151 public agencies disclosed to Parliament expenditure of \$115,421,268.77 relating to advertising agencies, market research, polling, direct mail, and media advertising agencies.

## 2. Public funding

Eligible political parties, candidates, and Legislative Council groups that participated in the State General Election, held on 13 March 2021, could submit a claim for reimbursement of their electoral expenditure by 2 August 2021. Reimbursement of electoral expenditure is authorised where a candidate has received more than four percent of the total formal votes. The figure to be reimbursed is the lesser amount of electoral expenditure or the amount determined by using the public funding figure (\$1.96699) per first preference vote received. Two Independent candidates and seven political parties qualified to lodge claims. The last claim was approved on 29 July 2021, and all claims were available to be viewed on the Commission's website from 30 August 2021.
