Dear President

Following the reconstitution of the Ministry on 8 June 2023, I wish to advise of the following two matters relating to the allocation of Portfolio responsibilities.

Firstly, the Hon Rita Saffioti MLA, Minister for Transport and the Hon David Michael MLA, Minister Assisting the Minister for Transport, have agreed on the allocation of matters within the Transport portfolio.

The Minister Assisting the Minister for Transport will take responsibility for the matters detailed on the attached list (Attachment 1) on behalf of the Minister for Transport.

The Minister for Transport will continue to be legally responsible for all statutes allocated to her by the Governor, however, the Minister Assisting the Minister for Transport will act on her behalf regarding decisions relating to the relevant matters.

Secondly, the Hon Rita Saffioti MLA, Treasurer and the Hon John Carey MLA, Minister for Planning, have agreed that the Treasurer will take responsibility for the following matters within the Planning portfolio:

- Market-led Proposals policy and processes; and
- Perth City Deal Agreement as it relates to the Western Australian Cricket Association (WACA) Ground and Aquatic Facility.

The Minister for Planning will continue to be legally responsible for all statutes allocated to him by the Governor.

The Hon Sue Ellery MLC currently represents the Minister Assisting the Minister for Transport; the Hon Stephen Dawson MLC represents the Minister for Transport and the Hon Jackie Jarvis MLC represents the Minister for Planning in the Legislative Council. There are no changes to those arrangements.
