C1276. Hon Colin de Grussa to the Minister for Agriculture and Food representing the Minister for Housing

My question without notice of which some notice has been given is to the Minister representing the Minister for Housing.

I refer to Government Regional Officer Housing (GROH), and I ask:

- 1. What is the number and location of GROH currently under construction?
- 2. What is the number and location of GROH currently under lease from the private market?
- 3. What is the total number of GROH currently allocated, listed by region and client agency?

In the 2023/24 State Budget, the State Government invested an additional \$61.6 million into the Government Regional Officer Housing (GROH) program.

GROH is delivered based on client agency demand. If client agencies request housing in certain regions, the Department of Communities works with the client agency to allocate and deliver properties to suit the needs of those agencies.

Since 1 July 2020, more than 160 GROH homes have been added to the system. As at 31 July 2023, there were a further 25 GROH new builds under contract.

As at 31 July 2023, there were 4,886 GROH properties allocated to client agencies across the State. Of these, 2,455 were leased from the private market.

I table the following information which provides a breakdown of new builds under contract by region and leased properties by client agency.
