CHAPTER 2

Work of the Legislative Council Chamber

Work of the Chamber

This chapter provides data and analysis on the work of the Legislative Council Chamber during 2022, as well as year to year (historical) comparisons.

The effect of the different procedural arrangements on the work of the House is considered, focusing on the impact upon Government business.

E-Petitions

Following the Standing Orders Review in 2021,² the Council adopted a Temporary Order to trial and facilitate the presentation of e-petitions to the Council:³

TEMPORARY ORDER

BY RESOLUTION OF THE HOUSE ON 9 SEPTEMBER 2021

Duration of Temporary Order
 This Temporary Order applies from 1 January 2022 until 31 March 2023.

2. E-Petitions

- (1) An e-petition is a petition
 - (a) in the correct form prescribed by Standing Order 101;
 - (b) facilitated by a Member and lodged with the Clerk for publication on the Parliament's website for a nominated period ("posted period");
 - (c) by which persons must indicate their support of ("join the petition") by electronically providing their name, address (including postcode) and email address, and signifying their intention to join the petition.
- (2) The posted period for an e-petition is to be a minimum of one week and a maximum of six months from the date of publication on the Parliament's website.
- (3) The Member facilitating the e-petition must provide the Clerk with the details of the petition in the correct form, the posted period and a signed acknowledgment that they are prepared to facilitate the e-petition.
- (4) Once published on the Parliament's website an e-petition cannot be altered other than by order of the President.
- (5) Only one e-petition dealing with substantially the same grievance and requesting substantially the same action by the Council shall be published on the Parliament's website at the same time.
- (6) Only residents of Western Australia will be eligible to join an e-petition.

- (7) Once the posted period for an e-petition has elapsed, a paper copy of the Petition shall be printed by the Clerk in full (including the details of the persons who joined the petition) and presented to the Council by the Member that facilitated the e-petition.
- (8) An e-petition published on the Parliament's website, but not presented to the Council prior to the prorogation of the Parliament or the dissolution of the Legislative Assembly, may be presented to the subsequent Parliament and become a petition of the subsequent Parliament.
- (9) An e-petition may be facilitated during any adjournment of the Legislative Council and during any period of prorogation.
- (10) Persons must join an e-petition by filling out their correct details and personally agreeing to join the e-petition, and by no one else, except in the case of incapacity from sickness or disability.
- (11) A person cannot sign or join an e-petition more than once.
- (12) Only the name and address of the Principal Petitioner shall be made public on the Legislative Council's website.
- (13) The Clerk may decline to publish an e-petition on the website not in conformity with these Orders and shall advise the facilitating Member accordingly.
- (14) The Clerk or any Member may seek a ruling from the President of the Legislative Council relating to the conformity or otherwise of any e-petition with these Orders.
- (15) The Clerk is authorised to create and maintain an appropriate website on which to publish e-petitions and other explanatory information and do all things necessary in order to give effect to these Orders.
- (16) The Clerk must dispose of all electronic personal data relating to the posting and joining of an e-petition within six months after an e-petition is printed and presented to the Legislative Council.
- (17) The Standing Orders for petitions have application to e-petitions insofar as they can be applied.

The Temporary Order established a mechanism that facilitated a modern way of petitioning the Parliament in conformity with the standing rules and orders of the Legislative Council. The Temporary Orders provided an assurance to the Council that any petition hosted on the Parliament of Western Australia's website will correspond with its usual rules, and that the petitions were supported by Western Australian citizens concerned with Western Australian issues.

The first e-petition was hosted from 2 February 2022, closed on 16 March 2022, and was tabled on 17 March 2022 with 2116 electronic signatures.

In 2022, a total of 22 e-petitions were tabled. These petitions, complemented the 17 traditional hard copy petitions presented.

The Urgent Bills process

The Urgent Bills process was adopted by the Council on 9 September 2021.⁴ The new Standing Order 125A was first utilised on 16 March 2022.

Under the Urgent Bills process, a Minister or Parliamentary Secretary may declare a Bill urgent following the moving of the second reading speech, or at any time when the Order of the Day is called for debate. Once declared urgent, a Minister or Parliamentary Secretary may move a further motion setting proposed time limits to be applied to each of the remaining stages of the Bill. The motion is debateable for a maximum period of 30 minutes.

In 2022, Standing Order 125A (Urgent Bills) was used on five occasions:

- Small Business Development Corporation Amendment (COVID-19 Response) Bill 2022
- COVID-19 Response Legislation Amendment (Extension of Expiring Provisions) Bill 2022
- Planning and Development Amendment Bill 2022
- Emergency Management Amendment (Temporary COVID-19 Provisions) Bill 2022
- Medicines and Poisons (Validation) Bill 2022

Demise of the Crown

The passing of Her Majesty Queen Elizabeth the Second on 8 September 2022 had a profound impact on the Council with several conventions and procedures being revived to provide the appropriate acknowledgement for the passing of a Sovereign.

On Tuesday, 13 September 2022 the Council received a message from the Governor advising of the demise of the Crown and the proclamation of his Majesty King Charles the Third as the King of Australia. It read:

The Governor, with deep regret, formally informs the Legislative Council of official advice provided to him that Her Majesty Queen Elizabeth the Second passed away on 8 September 2022.

The Governor further informs the Legislative Council that his Majesty, King Charles the Third, has been proclaimed King of Australia and his other Realms and Territories, and Head of the Commonwealth, as confirmed by the Governor in Executive Council on 11 September 2022.

In response, the Council passed an Address of Condolence to be presented to the King by the Governor. An Address of Congratulations to the newly appointed King was also agreed to. The Council then adjourned for the remainder of the sitting week. The addresses were presented to His Excellency the Governor, by the President of the Legislative Council, on 15 September 2022.

When the Council returned on 20 September 2022, the Leader of the House moved a Motion of Condolence giving all Members the opportunity to express their condolences.

A special adjournment was agreed to, vacating the Council's next sitting, in order to observe the National Day of Mourning on Thursday, 22 September 2022.








Figure 3. Days and hours of sitting 2018 — 2022





Figure 4 shows Government business time compared with total sitting time from 2018 to 2022.

Figure 5. *Bills passed 2018 — 2022*





Figure 6 compares the number of Bills passed by the Council with the pages of legislation within the Bills passed from 2018 to 2022.




Bills considered and passed by the Council

In 2022 the Council passed 48 Bills. Of these, 6 were amended.

Leave was granted on 15 occasions to dispense with the Committee of the Whole House stage and to proceed forthwith to the Third Reading of a Bill.

Initiation of Bills

CHAPTER 3

Work of the Legislative Council Committees

The Legislative Council Committee Office

The Legislative Council Committee Office (Committee Office) supports the work of standing and select committees. A team of professional staff provide research, administration and executive services to individual committees. The statistical overview in Appendices 5 and 6 demonstrate the range and nature of the work of this office.

Committee operations

In 2022, the Committee Office supported and administered 5 standing committees, 2 joint standing committees and 2 select committees.

Standing committees

The terms of reference for each standing committee are established under the *Standing Orders of the Legislative Council* and continue from one Parliament to the next.

The Legislation Committee and the Uniform Legislation and Statues Review Committee scrutinise Bills referred to them by the Council.

The Joint Standing Committee on Delegated Legislation (Delegated Legislation Committee) considers disallowable subsidiary legislation including regulations, local laws, by-laws and some orders. The Delegated Legislation Committee can recommend the Council disallow subsidiary legislation which, if disallowed, ceases to have effect.

The Environment and Public Affairs Committee considers all petitions presented to the Council and has powers to initiate inquiries related to broader environmental issues.

The Public Administration Committee examines most aspects of public administration, and consults with statutory office holders.

The Estimates and Financial Operations Committee focuses on how public money is allocated and used. This function extends to scrutiny of the Annual State Budget and agencies' annual reports.

The Joint Standing Committee on Audit (Audit Committee) has specific functions set out in the *Auditor General Act 2006.*

The Procedure and Privileges Committee reviews the procedures of the House and its committees, and make recommendations to the House to assist or improve them. Issues of privilege are also referred to the Committee.

Select committees

Select committees are established to carry out a specialised inquiry into a particular matter. They dissolve once the inquiry is complete or if Parliament is prorogued. One select committee was established in 2022. The Select Committee into Child Development Services was established on 31 August 2022 to examine various issues relating to child development in Western Australia. These include the role of child development services on a child's overall development, health and wellbeing and the delivery of services in both metropolitan and regional Western Australia. The inquiry is ongoing.

The Select Committee into Cannabis and Hemp, established in October 2021, continued its inquiry on the potential to amend current legislation applying to medicinal cannabis and industrial hemp in Western Australia.

Reports and inquiries

Council committees tabled 14 reports in 2022.

Travel

On occasion committees undertake travel to collect evidence during an inquiry. Travel may include hosting hearings in regional Western Australia, inspecting locations and sites, or visiting locations where particular expertise or experience exists. Committees may also travel for the purposes of attending conferences and forums to inform themselves.

The Select Committee into Cannabis and Hemp undertook the following travel:

- attending the Australian Medicinal Cannabis Symposium in Queensland
- meeting 4 hemp growers and medicinal cannabis producers in South West Western Australia
- meeting stakeholders in the Czech Republic, Germany and Israel.








